Release and Waiver

This Agreement between _____ (hereinafter referred to as "Client") and Sarah-Jane Petti acting as agent for TLC Training and Consulting (hereinafter known as "Trainer") pertains to the following:

For good and valuable consideration, the parties agree as follows:

General Release

I have voluntarily enrolled in a dog training class, drop-in socialization class, dog trial, seminar, or other dog related activity, as a participant or spectator with TLC Training and Consulting. The undersigned hereby releases and waives any claims that the undersigned may now or hereafter have against the dog training facility, Hounds Lounge, dog training activity sponsor(s), Sarah-Jane Petti, TLC Training and Consulting, her instructors, coaches or their assigns from and against any and all liabilities, losses, damages, costs or expenses of whatever kind or nature, including attorney's fees, which the undersigned may incur as a result of any injury to the undersigned or their dog(s), or personal property of the undersigned as a result of the undersigned's activities undertaken at said facility including, without limitation, personal injury and damages thereof including loss of income, earnings, bodily injury, pain and suffering, emotional or mental distress and any and all medical expenses.

Assumption of Risk

I understand that attendance at a dog training class is not without risk to myself, members of my family or guests who may attend, or my dog, because some of the dogs to which I (we) will be exposed may be difficult to control and may be the cause of injury even when handled with the greatest amount of care. The undersigned acknowledges and understands that the dog training activities undertaken involve potential risk of personal injury and injury to personal property including dogs which may result from the undersigned's participation in dog training activities.

I am aware that while participating in the class, I and my dog may be exposed to a variety of environmental conditions which include but are not limited to all types of vehicular traffic, interaction with people and other animals, and exposure to adverse weather. The undersigned further acknowledges that these dog training activities are potentially dangerous and assumes all risk of injury and l or damage which may result from any reason whatsoever thereby.

Binding Effect

This Agreement is binding upon Client, spouse of Client, and children of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Trainer regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything else. Without limiting the generality of the foregoing, Client acknowledges that Trainer has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the results of the training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by both Client and Trainer.

IN ADDITION

Initial I hereby certify that any dog I may bring to class, to the best of my knowledge, is in good health, free of communicable diseases, and has had all precautionary vaccinations and protection which may be deemed appropriate by the Client's veterinarian for the safety and well being of all human and canine participants attending the classes.

Initial I hereby agree to abide by the rules of TLC Training and Consulting, that **no dog** shall be **physically reprimanded** while engaged in any activity sponsored by or affiliated with TLC Training and Consulting, or while on the premises leased or rented by TLC Training and Consulting (with the exception of dogs committing acts of aggression towards people or other dogs). I further understand that any violation of this agreement could lead to the immediate termination of my involvement in the event or activity (including being asked to leave the premises) without refund of any monies paid for that event or activity.

Initial I agree that I may be dismissed from any and all classes at any time, with or without cause, and in such event no portion(s) of my prepaid training fees will be refunded. At Trainer's sole election, Trainer's duties hereunder shall terminate if in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, or interferes with the training of other dogs.

I HAVE READ THIS AGREEMENT CAREFULLY, FULLY UNDERSTAND ITS CONTENTS, AND AM VOLUNTARILY SIGNING BELOW. I AM AWARE THAT THIS IS A RELEASE OF ALL LIABILITY AND A BINDING CONTRACT.
